Entry Period:

Beginning on **August 4th, 2026** and ending on **August 20th, 2026** (the "Entry Period"). All entries must be received during the Entry Period to qualify.

1. Eligibility

The Ishay Ribo VIP Experience Sweepstakes (the "Sweepstakes") is open to legal residents of the United States who are eighteen (18) years of age or older at the time of entry.

Employees, officers, directors, representatives, agents, and immediate family members of American Friends of Migdal Ohr employees, and individuals involved in administering the Sweepstakes, are not eligible to enter or win.

2. How to Enter

There are two methods of entry:

Option 1 - Voluntary Donation Entry

A donation is completely voluntary. No donation is required to enter or win.

No goods or services were provided in exchange for your donation.

Option 2 - Free Alternative Method of Entry (AMOE)

To enter without making a donation, eligible participants may submit a free mail-in entry.

3. Entry Limitations

Each individual may submit no more than 1 eligible entries during the Entry Period.

The use of robotic, automatic, programmed, or similar entry methods is prohibited.

Sponsor's computer system shall be the official timekeeping device for the Sweepstakes.

6. Winner Notification

The potential winner will be notified by email or telephone using the contact information provided at entry.

The potential winner must respond within three (3) calendar days of notification and may be required to provide eligibility verification, a completed affidavit of eligibility, liability release, publicity release, and tax documentation, including a completed IRS Form W-9 if required.

If the potential winner cannot be contacted, fails to respond within the required timeframe, is determined to be ineligible, or fails to complete required documentation, Sponsor may select an alternate winner.

7. Publicity

Except where prohibited by law, acceptance of the prize constitutes permission for American Friends of Migdal Ohr to use the winner's name, city and state of residence, photograph, likeness, and statements for promotional and fundraising purposes without additional compensation.

8. Privacy

Information collected from entrants will be used for purposes of administering the Sweepstakes, verifying eligibility, contacting winners, and fulfilling the prize.

Information will be handled in accordance with American Friends of Migdal Ohr's privacy practices.

9. General Conditions

Sponsor reserves the right to cancel, suspend, modify, or terminate the Sweepstakes if fraud, technical failures, unauthorized intervention, or other circumstances compromise the integrity or operation of the Sweepstakes.

Sponsor reserves the right to disqualify any participant who tampers with the entry process, violates these Official Rules, or engages in fraudulent conduct.

10. Limitation of Liability

By entering, participants agree to release and hold harmless American Friends of Migdal Ohr and its officers, directors, employees, volunteers, agents, affiliates, representatives, and partners from any claims, damages, losses, liabilities, or expenses arising from participation in the Sweepstakes or acceptance, possession, or use of the prize.

11. Taxes

12. Governing Law and Disputes

The Sweepstakes and these Official Rules shall be governed by and construed under the laws of the State of New York.

Except where prohibited by law, entrants agree that any disputes arising from or relating to the Sweepstakes shall be resolved individually and not through any class action proceeding.
