OFFICIAL RULES

ROLEX CHARITABLE SWEEPSTAKES — FUNDRAISER NO. [____]

No purchase, payment, donation, or contribution is necessary to enter or win. A donation does not increase your chances of winning. Donors and non-donors are treated equally. This is a charitable drawing conducted under Florida Statute § 849.0935. Void where prohibited by law.

1. SPONSOR

This Charitable Sweepstakes (the "Drawing") is sponsored and administered by Chabad of Miami, a Florida not-for-profit organization, 3713 Main Highway, Miami, FL 33133 (the "Sponsor"). Federal Tax ID #65-0132853. Questions: raffle@chabad.miami.

2. NO PURCHASE OR DONATION NECESSARY

No purchase, payment, donation, or contribution is necessary to enter or win, and a donation will not improve your chances of winning. There are two ways to enter, and all entries—whether or not accompanied by a donation—are placed in the same Drawing and have an equal chance of winning.

3. ELIGIBILITY

The Drawing is open only to legal residents of the United States who are at least 18 years old (or the age of majority in their state of residence) as of the date of entry. Employees, officers, directors, and volunteers of the Sponsor, and their immediate family members (spouse, parents, children, siblings) and household members, are not eligible. Void where prohibited or restricted by law. By entering, each entrant agrees to be bound by these Official Rules and by the decisions of the Sponsor, which are final and binding in all matters.

4. ENTRY PERIOD

Entries for Fundraiser No. [____] will be accepted beginning [START DATE/TIME] and will close when all 500 entries have been filled, or on [BACKSTOP END DATE, if any], whichever occurs first (the "Entry Period"). Mail-in entries must be postmarked during the Entry Period and received no later than [X] days after the close of the Entry Period. Sponsor's clock is the official timekeeper.

5. HOW TO ENTER

(a) Donation Entry. Visit Rayze.it/chabadofmiami and complete the entry form. Every donor is entered into the Drawing as a thank-you for supporting Chabad of Miami. The donation amount does not affect the entrant's chance of winning.

(b) Free Mail-In Entry. To enter without a donation, hand-print on a sheet of paper (or use the official mail-in entry form) your full name, complete mailing address, email address, phone number, and the Rolex Fundraiser number you are entering, and mail it to: Chabad of Miami, Attn: Rolex Charitable Sweepstakes, 3713 Main Highway, Miami, FL 33133. **An entry is not valid unless it identifies the Rolex Fundraiser number being entered.**

Limit: one (1) entry per person per Fundraiser, regardless of method of entry. Duplicate, illegible, incomplete, or late entries are void. Automated, mechanically reproduced, or bulk entries are void.

6. NUMBER OF ENTRIES; DRAWING TRIGGER

Each Fundraiser is limited to a maximum of 500 entries. The Drawing will be conducted as soon as all 500 entries have been filled (or at the close of the Entry Period, if a backstop end date applies). Once 500 entries are filled, no further entries will be accepted for that Fundraiser.

7. ODDS OF WINNING

The odds of winning depend on the total number of eligible entries received, and will be no greater than 1 in 500. A donation does not change the odds of winning.

8. WINNER SELECTION AND NOTIFICATION

The winner will be selected in a random drawing from among all eligible entries. The Drawing will be conducted live on Instagram (@Ziv.Tamir). The Sponsor will notify the potential winner using the contact information provided at entry within [X] days of the Drawing. The potential winner may be required to sign and return an affidavit of eligibility, a liability release, and (where lawful) a publicity release, and to provide a completed IRS Form W-9, within [X] days of notification. If the potential winner cannot be contacted, is ineligible, fails to claim the prize, or fails to return required documents within the stated time, the prize may be forfeited and an alternate winner selected at random.

9. PRIZE

10. TAXES

All federal, state, and local taxes on the prize are the sole responsibility of the winner. Because the value of the prize exceeds \$600, the Sponsor is required to report the prize to the Internal Revenue Service on IRS Form 1099, and the winner must provide a completed IRS Form W-9 (including a valid Social Security or taxpayer identification number) before the prize will be released. The winner is advised to consult a tax professional.

11. PUBLICITY RELEASE

Except where prohibited by law, acceptance of the prize constitutes the winner's consent to the Sponsor's use of the winner's name, city and state of residence, photograph, likeness, voice, and statements for advertising, promotional, and publicity purposes in any media, worldwide, without further compensation, notice, or approval.

12. GENERAL CONDITIONS

The Sponsor reserves the right, in its sole discretion, to disqualify any entrant it finds to be tampering with the entry process or the operation of the Drawing, or acting in violation of these Official Rules. The Sponsor reserves the right to modify, suspend, or cancel the Drawing if fraud, technical failure, or any other factor beyond its reasonable control impairs the integrity or proper conduct of the Drawing; in such event, the winner will be selected from among all eligible, non-suspect entries received prior to the action taken.

13. LIMITATION OF LIABILITY

By entering, each entrant releases and holds harmless the Sponsor and its officers, directors, volunteers, and agents from any and all liability, injury, loss, or damage of any kind arising from or in connection with the Drawing or the acceptance, possession, or use of the prize. The Sponsor is not responsible for lost, late, misdirected, illegible, or postage-due mail, or for technical or human errors in the entry or administration of the Drawing.

14. DISPUTES; GOVERNING LAW

These Official Rules are governed by the laws of the State of Florida, without regard to conflict-of-law principles. Any dispute arising out of or relating to the Drawing shall be resolved exclusively in the state or federal courts located in Miami-Dade County, Florida, and entrants consent to the jurisdiction and venue of such courts.

15. PRIVACY

Information collected from entrants is used by the Sponsor to administer the Drawing and to communicate with entrants and donors about Chabad of Miami. The Sponsor does not sell entrant information. Entrants may unsubscribe from Sponsor emails at any time.
