

Yeshiva Shaarei Menachem Tesla Raffle 2022

Rules & Regulations:

You are responsible for reading these official rules and regulations.

The Grand Prize drawing will be held on February 15, 2022. The drawing is limited to a maximum of

1574 entrants. The winner will choose to receive either a Tesla Model 3 (when it becomes available), or \$35,000.00 USD.

If the winner chooses to customize the Tesla beyond the base Model 3 Rear-Wheel Drive specifications, he will be responsible for any costs, taxes, and fees.

To claim the Tesla prize, the winner must present a valid driver's license, Social Security Number (or equivalent thereof) and proof of insurance. To claim the \$35,000 Prize, the winner must present a Government issued I.D. and Social Security number (or equivalent thereof).

Prize draw dates, closing dates and times, and notification dates will be set out in the launch message and other accompanying content used to promote that particular prize draw and campaign.
