One Israel Fund Sweepstakes Official Rules

NO PURCHASE, DONATION OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE, DONATION OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

One Israel Fund Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States (and the District of Columbia) who are eighteen (18) years of age or older at the time of entry. Void where prohibited. Employees of One Israel Fund, Ltd. and its respective parents, affiliates, subsidiaries, distributors, sales representatives, and all other service agencies involved with the Sweepstakes and members of their immediate family (spouse, parents, siblings, and children) and household members (whether related or not) of each such employee are not eligible to participate or win. To enter the Sweepstakes or receive a prize, you must fully comply with the Official Rules and, by entering, you represent and warrant that you agree to be bound by these Official Rules and the decisions of the Sponsor, whose decisions shall be binding and final in all respects relating to this Sweepstakes.

2. Sponsor

3. Timing

Sweepstakes begins on March 6, 2025 at 12:00 a.m. ET and ends April 4, 2025 at 11:59 p.m. ET ("Sweepstakes Entry Period"). The Sweepstakes is governed by these Official Rules and is subject to all applicable federal, state and local laws.

4. How to Enter

There are three ways to enter during the Sweepstakes Entry Period:

- i. Receive an Entry When you Make a Donation. Go to www.oneisraelfund.org/winwithoif and donate. If you donate \$100 you will automatically receive one (1) entry into the Sweepstakes. If you donate \$250 you will automatically receive three (3) entries into the Sweepstakes. When you donate you will be required to provide information about yourself.
- ii. <u>Receive an Entry without Donating</u>. Go to www.oneisraelfund.org/sweepstakes and complete the online entry form. When you provide all required information you will automatically receive one (1) entry into the Sweepstakes.
- iii. Receive an Entry when you refer. If you refer others to the Sweepstakes using a custom link that the Sponsor provides you will receive one (1) entry for every five people that make a donation that entitles them to an entry.

Limit of forty (40) entries per person regardless of method of entry during the Sweepstakes Entry Period. Multiple participants are not permitted to share the same email address. Any attempt by any participant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that participant's entries and that participant may be disqualified. Use of any automated system to participate in the Sweepstakes is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified.

5. Winner Determination

On or about April 7, 2025, Sponsor will select one (1) entry for the grand prize described below in a random drawing of all valid entries received. The potential winner will be contacted using the email address and/or phone number provided with the registration and may be awarded the prize subject to verification of eligibility and compliance with the terms of these Official Rules. The potential winner will be notified on or about the date of the drawing. Failure by a potential winner to respond to any contact within 48 hours of notification will result in disqualification, and Sponsor will select an alternative potential winner in the same manner.

6. Odds

Odds of winning depend on the number of eligible entries received during the Sweepstakes Entry Period.

7. POTENTIAL WINNER IS SUBJECT TO VERIFICATION BY SPONSOR. SPONSOR'S DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE ADMINISTRATION, OPERATION, SELECTION OF THE WINNER AND OTHER MATTERS RELATED TO THE SWEEPSTAKES.

SPONSOR RESERVES THE RIGHT TO CONDUCT A BACKGROUND CHECK ON POTENTIAL WINNER (AND TRAVEL COMPANION), AND SPONSOR RESERVES THE RIGHT TO DISQUALIFY ANY POTENTIAL WINNER BASED ON SUCH BACKGROUND CHECK IF SPONSOR DETERMINES IN ITS SOLE DISCRETION THAT AWARDING A PRIZE TO ANY SUCH INDIVIDUAL MIGHT REFLECT NEGATIVELY ON SPONSOR OR ANY OF ITS PARTNERS. POTENTIAL WINNER WILL COOPERATE WITH SPONSOR AND ITS REPRESENTATIVES IN CONNECTION WITH ANY AND ALL VERIFICATION AND BACKGROUND CHECK ACTIVITIES, INCLUDING, WITHOUT LIMITATION, BY EXECUTING AND DELIVERING TO SPONSOR OR ITS DESIGNEE BY THE TIME INDICATED BY SPONSOR OR ITS DESIGNEE ANY VERIFICATION AND BACKGROUND CHECK AUTHORIZATION FORMS REQUIRED BY SPONSOR OR ITS DESIGNEE. FAILURE TO COOPERATE OR TIMELY SUBMIT ANY VERIFICATION OR BACKGROUND CHECK AUTHORIZATION MAY RESULT IN FORFEITURE OF THE PRIZE.

8. Verification of Potential Winner

Potential winner may be required to complete and return an Affidavit of Eligibility, Release of Liability and Publicity Release (where permitted by law) (collectively, the "Affidavit") by the date specified by Sponsor, or an alternate potential winner may be selected. In the event (a) potential winner cannot be reached for whatever reason after a reasonable effort has been exerted, or the potential winner notification or Affidavit is returned as undeliverable, (b) potential winner declines or cannot accept, receive or use the prize for any reason, (c) of noncompliance with these Official Rules or any of the aforesaid time periods, (d) potential winner is found to be ineligible to enter the Sweepstakes or receive the prize, or (e) potential winner fails to fulfill the Affidavit-related obligations, the potential winner shall be disqualified from the Sweepstakes and an alternate potential winner may be selected in a random drawing, from among the other eligible entries received. Sponsor reserves the right to modify the notification and Affidavit procedures in connection with the selection of alternate potential winner, if any.

9. Grand Prize

One grand prize will be awarded. Grand prize will be able to choose between a 5-night/6-day trip for winner and one (1) guest to Israel or \$25,000 as a cash alternative. Trip includes roundtrip airfare from Continental United States to Tel Aviv, Israel (for two people); five (5) nights hotel accommodations (single room / double occupancy); five thousand dollars (\$5,000) in spending money; and touring with One Israel Fund's group that includes Sid Rosenberg and Michael Rapaport, subject to change and availability.

If Sid Rosenberg and/or Michael Rapaport are not able to join the tour no other prizing will be offered. Additionally there is no commitment how long Sid Rosenberg and/or Michael Rapaport will be on the tour, if at all. Approximate retail value of grand prize is \$25,000.

Sponsor in its sole discretion will determine date of trip. It is anticipated that the trip will be on or about the last week of April 2025. If grand prize winner is unable to go on the trip on the stated dates and did not select the cash option (\$25,000), grand prize winner forfeits the grand prize in its entirety. Once winner selects trip they will be required to go on the trip or forfeit the prize. Sponsor in its sole discretion reserves the right to cancel or postpone the trip at anytime. If the trip is canceled the Sponsor will award the grand prize winner the \$25,000 cash alternative.

Sponsor will determine airline, flight itinerary and hotel and accommodations in its sole discretion. Trip must be round trip. No refund or compensation will be made in the event of the cancellation or delay of any flight. Travel and accommodations are subject to availability. Travel is subject to the terms and conditions set forth in this Sweepstakes, and those set forth by the Sponsor's airline carrier of choice as detailed in the passenger ticket contract. Prize is non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the Grand Prize (or a component thereof) for one of equal or greater value if the designated prize should become unavailable for any reason. Some restrictions may apply. Meals not described above, incidentals, tips, telephone calls, or any other personal expenses incurred during the trip are the responsibility of the Grand Prize Winner. All other expenses not specifically identified as included in the Grand Prize are the sole responsibility of the Grand Prize Winner. Grand prize winner and travel companion is responsible for obtaining all necessary travel documents (valid Passport) travel insurance (and all other forms of insurance) at their option and hereby acknowledge that the Sponsor has not and will not obtain or provide travel insurance or any other form of insurance. Grand prize winner and travel companion must travel the same itinerary and on the dates and/or times specified by Sponsor or prize will be forfeited in its entirety. Once the travel companion is selected, they may not be substituted, except at the Sponsor's sole discretion. Grand prize winner and travel companion are solely responsible for obtaining any identification documents necessary for international travel. Travel companions of winner must be at least eighteen (18) years of age or older, and must sign a Liability and Publicity Release. If potential winner's travel companions fail to return such documents within date and/or time indicated within such documents, then the potential winner may forfeit the right to those travel companions.

In the event that winner and/or his or her guest engage in behavior that (as determined by Sponsor or in their sole and absolute discretion) is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten, or harass any other person, Sponsor reserves the right to terminate the trip, in whole or in part, and send winner and/or his or her guest home with no further compensation.

If less than 1250 entries are received from individuals who donate, the trip to Israel (and option for the cash alternative of \$25,000) will not be provided as the grand prize. Rather the grand prize winner will receive 25% of the value of donations up to \$25,000 that were made via method one above, subject to a minimum of a prize of \$1,000.

Winner is responsible for all taxes and fees associated with prize receipt and/or use. All federal, state, and local tax liabilities, as well as any other costs and expenses not specified herein as being awarded are the sole responsibility of the Winner. Winner may be required to complete and return an IRS W-9 form (i.e. Request for Taxpayer Identification Number and Certification). Prize will be awarded only if the potential prize winner fully complies with these Official Rules.

10. Entry Conditions and Release

Each entrant agrees to: (a) comply with and be bound by these Official Rules and the decisions of Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) defend, indemnify, release and hold harmless the Sponsor and its respective parent, subsidiary, and affiliated companies, celebrities, and any other person and organization responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes, and all of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Sweepstakes, acceptance, possession, attendance at, defect in, delivery of, inability to use, use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry. Winner acknowledges that the prize is awarded as-is without warranty of any kind.

11. Publicity

Except where prohibited or restricted by law, winner's acceptance of prize constitutes the winner's agreement and consent for Sponsor and any of its designees to use and/or publish winner's name, city and state of residence, photographs or other likenesses, pictures, portraits, video, voice, testimonials, biographical information (in whole or in part), and/or statements made by winner regarding the Sweepstakes or Sponsor, worldwide and in perpetuity for any and all purposes, including, but not limited to, advertising, trade and/or promotion on behalf of Sponsor, in any and all forms of media, now known or hereafter devised, including, but not limited to, print, TV, radio, electronic, cable, or World Wide Web, without further limitation, restriction, compensation, notice, review, or approval.

12. General Conditions

Sponsor and its subsidiaries, affiliates, divisions, partners, representatives, agents, successors, assigns, employees, officers and directors shall not have any obligation or responsibility, including any responsibility to award any prize to entrants, with regard to: (a) entries that contain inaccurate information or do not comply with or violate the Official Rules; (b) entries, prize claims or notifications that are lost, late, incomplete, illegible, unintelligible, damaged or otherwise not received by the intended recipient, in whole or in part, due to computer, human or technical error of any kind; (c) entrants who have committed fraud or deception in entering or participating in the Sweepstakes or claiming the prize; (d) telephone, electronic, hardware, software, network, Internet or computer malfunctions, failures or difficulties; (e) any inability of the winner to accept the prize for any reason; (f) if a prize cannot be awarded due to delays or interruptions due to Acts of God, natural disasters, terrorism, weather or any other similar event beyond Sponsor's reasonable control; or (g) any damages, injuries or losses of any kind caused by any prize or resulting from awarding, acceptance, possession, use, misuse, loss or misdirection of any prize or resulting from participating in this Sweepstakes or any promotion or prize related activities. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be (a) tampering with the entry process or the operation of the Sweepstakes, or with any Website promoting the Sweepstakes; (b) acting in violation of the Official Rules; or (c) entering or attempting to enter the Sweepstakes multiple times through the use of multiple email addresses or the use of any robotic or automated devices to submit entries. If Sponsor determines, in its sole discretion, that technical difficulties or unforeseen events compromise the integrity or viability of the

Sweepstakes, Sponsor reserves the right to void the entries at issue, and/or terminate the relevant portion of the Sweepstakes, including the entire Sweepstakes, and/or modify the Sweepstakes and/or award the prize from all eligible entries received as of the termination date.

13. Limitations of Liability

The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (b) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Sweepstakes; (d) technical or human error in the administration of the Sweepstakes or the processing of registrations; or (e) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. If for any reason an entrant's registration is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes. No more than the stated number of each prize will be awarded.

14. Disputes

Except where prohibited, by participating, entrants agree that all issues and questions concerning the construction, validity, interpretation, administration, and enforceability of the Official Rules, or the rights and obligations of an entrant and Sponsor shall be governed by and construed exclusively in accordance with the laws of the state of New York without giving effect to any principles of conflicts of law of any jurisdiction and that: (1) any and all disputes, claims, and causes of actions arising out of, or connected with the Sweepstakes, shall be resolved individually, without resort to any form of class action; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with participating, but in no event attorney's fees; (3) under no circumstances will any entrant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. By entering the Sweepstakes, all entrants agree to be subject to jurisdiction in the Federal and State courts of Nassau County, New York and agree that all disputes relating in any way to this Sweepstakes must be resolved in the courts of New York. Entrants agree not to raise the defense of forum non convenience.
