

## **THE “ONE CHANCE” SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE OR DONATION NECESSARY. A PURCHASE OR DONATION WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW.**

**1. Entry Period.** The “ONE CHANCE” Sweepstakes (“Sweepstakes”) begins May 8,2020 at 12:01am EST and ends June 18,2020 at 11:59pm EST (“Sweepstakes Period”).

**2. Eligibility.** Open to individual legal residents of the 50 United States and the District of Columbia, Canada (excluding Quebec), age 18 or older who have reached the age of majority in the Participant’s state of residence as of May 8, 2020 (each a “Participant”). Sponsor and its affiliates, and their respective employees (and their immediate families and members of the same household), officers, directors, and agents may not participate in this Sweepstakes.

**3. How to Enter.** Individuals making donations of \$100 or more by mail, email, or online through the Sweepstakes website at [https:// www.rayze.it/rcp](https://www.rayze.it/rcp) (“Website”) will be automatically entered into the Sweepstakes as follows: \$100 donation = 1 entry. Mail-In Donations should be sent to The Rosh Chodesh ProjectINC, 9 Lois Lane , Spring Valley NY,10952 and should include the number of tickets in the check memo, and credit card information or check payable to “The Rosh Chodesh Project.” Please specify the number of entries to be included in the drawing. To enter without making a donation, mail a postcard (no larger than 5” x 7”) in a #10 envelope with proper postage affixed to The Rosh Chodesh ProjectINC, 9 Lois Lane , Spring Valley NY,10952 and legibly hand-print your first and last name, home address, telephone number, and e-mail address, with the following statement: “Please enter me into the “ONE CHANCE Sweepstakes”. One entry per mail-in request. Each mail-in request must be mailed in separately. All donations and mail-in requests must be received no later than May 15,2020 to be eligible. Limit 250 entries per person/ household/email address, regardless of method of entry. Sweepstakes entries will not be acknowledged. Information collected by Sponsor may be used by Sponsor to communicate with Participants about the Sweepstakes or Sponsor’s program activities. Information collected by Sponsor as part of this Sweepstakes are subject to the privacy.

**4. Prizes.** The winner of the drawing will win one year of your mortgage or rent being paid in 12 payments monthly by the “Sponsor”. The value won is based on your mortgage/rent monthly amount written in your legal contract as of May 8, 2020. The maximum value in US dollars eligible to win is \$50,000.

**5. Selection of Winners.** The Drawing will be held when 2000 tickets are sold (latest date of drawing will be June 18,2020) and conducted by representatives of Sponsor whose decisions are final. The Winners will be notified by email or telephone on or about one (1) day after the date of the Drawing. The odds of winning depend on the total number of entries received.

**6. Verification of Winners and Delivery of Prize.** The Winners may be required to sign an affidavit of eligibility and liability release and, where permitted, a publicity release, which must be returned within 15 days of prize notification. Limitation of Liability.** Sponsor, in its sole discretion, reserves the right to suspend, cancel or modify the Sweepstakes without notice or liability if the integrity of the Sweepstakes is compromised in any manner as determined by Sponsor, or if the Sweepstakes is not capable of being conducted as intended by Sponsor. In the event of any such cancellation, termination or suspension, a notice will be posted and a random drawing will be held from among all eligible, non-suspect entries received prior to such time. Sponsor reserves the right, at its sole discretion, to disqualify any Participant from this Sweepstakes or any other promotion conducted now or in the future by Sponsor if he/she tampers with the entry process or if his/her misconduct affects the integrity of the Sweepstakes. Governing Law.** Except where prohibited, Participant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with the Sweepstakes or any Prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in New York, New York, USA; (b) all issues and questions concerning these Official Rules and the Sweepstakes shall be governed by and construed in accordance with the laws of New York, USA, without giving effect to any choice of law or conflict of law rules.
