

# THE YAD ELIEZER SWEEPSTAKES

## OFFICIAL RULES

**NO PURCHASE OR DONATION NECESSARY. A PURCHASE OR DONATION WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW.**

- 1. Entry Period.** The Yad Eliezer Sweepstakes ("Sweepstakes") begins January 10th, 2019 at 12:01am EST and ends November 30th, 2019 at 11:59pm EST ("Sweepstakes Period").
- 2. Eligibility.** Open to individual legal residents of the 50 United States and the District of Columbia, age 18 or older who have reached the age of majority in the Participant's state of residence as of January 10, 2019 (each a "Participant"). Sponsor and its affiliates, and their respective employees (and their immediate families and members of the same household), officers, directors, and agents may not participate in this Sweepstakes.
- 3. How to Enter.** Individuals making donations of \$50 or more by mail, email, or online through the Sweepstakes website at <https://www.rayze.it/yadeliezer-sweepstakes/> ("Website") will be automatically entered into the Sweepstakes as follows: \$50 donation = 1 entry; \$180 donation = 4 entries; \$360 = 10 entries; \$600 = 18 entries; \$1,000 = 35 entries; \$5,000 = 250 entries. Participant must designate one of the five prize drawings for each entry. Mail-In Donations should be sent to American Friends of Yad Eliezer, 410 Glenn Road, Jackson, NJ 08527, and should include the completed Mail-In Donation entry form, and credit card information or check payable to "American Friends of Yad Eliezer." Please specify the number of entries to be included in each applicable prize drawing. To enter without making a donation, mail a postcard (no larger than 5" x 7") in a #10 envelope with proper postage affixed to American Friends of Yad Eliezer, 410 Glenn Road, Jackson, NJ 08527, and legibly hand-print your first and last name, home address, telephone number, and e-mail address, with the following statement: "Please enter me in the Yad Eliezer Sweepstakes" and specify the prize drawing to be entered. One entry per mail-in request. Each mail-in request must be mailed in separately. All donations and mail-in requests must be received no later than November 30, 2019 to be eligible. If a prize drawing is not selected for any entry, the undesignated entry will be submitted into the drawing for the \$10,000 Cash prize. Limit 250 entries per person/household/email address, regardless of method of entry. Sweepstakes entries will not be acknowledged. **5. Selection of Winners.** The Drawing will be held on November 30th, 2019 and conducted by representatives of Sponsor whose decisions are final. The Winners will be notified by email or telephone on or about one (1) day after the date of the Drawing. The odds of winning depend on the total number of entries received.

**6. Verification of Winners and Delivery of Prize.** The Winners may be required to sign affidavit of eligibility and liability release and, where permitted, a publicity release, which must be returned within 15 days of prize notification. Each Prize may be awarded to an alternate Winner if the Winner cannot be reached within seven (7) days after Sponsor contacts the Winner by telephone or e-mail, if the e-mail notification or Prize is returned as undeliverable or Sponsor cannot reach Winner by telephone, or if the affidavit/release is not returned within five (5) business days after it is sent to the Winner. Limitation of Liability.** Sponsor, in its sole discretion, reserves the right to suspend, cancel or modify the Sweepstakes without notice or liability if the integrity of the Sweepstakes is compromised in any manner as determined by Sponsor, or if the Sweepstakes is not capable of being conducted as intended by Sponsor. In the event of any such cancellation, termination or suspension, a notice will be posted and a random drawing will be held from among all eligible, non-suspect entries received prior to such time. Sponsor reserves the right, at its sole discretion, to disqualify any Participant from this Sweepstakes or any other promotion conducted now or in the future by Sponsor if he/she tampers with the entry process or if his/her misconduct affects the integrity of the Sweepstakes. Sponsor is not responsible for printing or typographical errors in any Sweepstakes materials, or by any human or other errors that may occur in connection with this Sweepstakes.

Release and Indemnity.** Participant releases Sponsor and its respective affiliates, successors, licensees, and assigns, and each of their officers, directors, agents, employees (the "Indemnitees") and any parties associated with the development and execution of this Sweepstakes, from any and all liability with respect to, or in any way arising from, this Sweepstakes, including, but not limited to, any suspension, modification or cancellation of the Sweepstakes, and/or acceptance or use of the donation, including liability for personal injury, death, damages or loss. Governing Law.** Except where prohibited, Participant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with the Sweepstakes or any Prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in New York, New York, USA; (b) all issues and questions concerning these Official Rules and the Sweepstakes shall be governed by and construed in accordance with the laws of New York, USA, without giving effect to any choice of law or conflict of law rules.
